## SCHOOL OF NURSING – Health Sciences Compensation Plan Outside Activity Guide

Time Limits –all reportable outside activity must not exceed 48 days (384 hours)

**Earnings Threshold**: The maximum annual earnings for outside professional activities is \$40,000 or 40% of the fiscal-year base salary scale (scale 0), whichever is greater, for an individual faculty member's rank and step. Activities performed during paid and unpaid leaves of absence (e.g. vacation, holidays, week-ends) counts toward the time and earning limits. Income earned above the threshold must be deposited to the Plan. Income from Category III activities and certain other activities listed below are exempt from being deposited into the plan. Refer to SON Implementing Procedures for disclosing Stock Options/Non-cash compensation.

Each Plan member is responsible for keeping a running (fiscal year) total of his/her time devoted to and earning derived from outside professional activities [Refer to the Implementing Procedures for the process on how to submit an exception request for the time and/or earnings threshold].

Patient care activity – we define it as the direct delivery of clinical services to patients – either individual patients, groups of patients, families, or staff. We also include supervision and teaching in the clinical environment in the definition of "clinical care".

Advance written approval must be requested for any of the following:

- Category I activities (see end of document)
- Any outside professional activity involving students or the use of University resources
- All requests to exceed the time and/or earning limits

## Category I – All category I activities require review and approval/denial prior to being undertaken by the Plan member

Category I activities are most likely to create a conflict of commitment because: 1) they are activities related to the training and expertise which is the individual's qualification for University appointment, but performed for third party, and /or 2) they require a significant professional commitment. Category I activities require **prior** approval by the Department Chair/ORU Director, Dean or his/her designee, and Chancellor. Approvals are generally for one fiscal year but may be granted for a longer term, not to exceed five years. Category I activities count towards the Plan Participant's time limits and earnings thresholds. These activities include but are not limited to:

- Teaching, research, or administration of a grant at an educational institution, trust, organization, government agency, foundation or other entity outside of the University. (Grants submitted on behalf of a professional society are exempt from this restriction, i.e., they are not considered Category I activities.);
- Employment outside of the University;
- Assuming a founding/co-founding role of a company
- Assuming an executive or managerial position outside of the University (excluding position with professional societies)
