- Faculty Council consists of two elected representatives from each of the four SON departments, at least one of whom must be a member of an Academic Senate series. Elected FC members shall hold office for a full term of 2 years beginning with the first day of September.
- Members of the Standing Committees shall serve a term of at least 2 years starting September 1 and ending August 31.
- The MS Program Council shall include two representatives from each department, with the exception of Social and Behavioral Sciences, which shall have one representative, and each clinical department must include a Nurse Practitioner as one of their representatives.
