MEMORANDUM OF UNDERSTANDING (MOU) UCSF ACADEMIC SENATE REVIEW OF OUTSIDE RESEARCH AFFILIATION AGREEMENTS

The purpose of this memorandum of understanding (MOU) is to formalize the agreement between the UCSF Academic Senate and the Chancellor regarding negotiating and executing Research Affiliation Agreements.

Review of Outside Research Affiliation Agreements

For the purposes of this MOU, an Outside Research Affiliation Agreement is one that impacts faculty or student status at UCSF and is between UCSF and a private research institute or foundation, or a Medical Research Organizations as defined in the Internal Revenue Code.

In cases where a new Outside Research Affiliation Agreement is being negotiated, the Chancellor or Chancellor's Designee shall notify the Academic Senate Chair and Chair's Office of the negotiation and provide the Senate an opportunity to review and comment on the draft agreement before approval by the Chancellor.

Outside Research Affiliation Agreements will be reviewed by the chair(s) of Graduate Council and/or the Committee on Research, with consultation from their respective committee membership(s), to assess draft agreements for potential issues of concern. All Senate members reviewing draft agreements must acknowledge and abide by applicable confidentiality or non-disclosure terms related to a particular agreement.

The Academic Senate shall have ten business days to review the draft agreement and provide the Chancellor's Office with comments.

Notwithstanding the foregoing, the Chancellor has the ultimate authority to approve Outside Research Affiliation Agreements. The Chancellor also has the authority to sign non-binding term sheets or similar non-binding agreements before a final Outside Research Affiliation Agreement is negotiated and shall notify the Academic Senate Chair and Chair's Office.
