Space Governance and Principles

The Senate's Space Committee (SPC) continued to discuss UCSF's Space Governance and Principles policy which is covered by [Campus Administrative Policy 600-24](#). The committee endorsed the report from the Research Space and Administration Policy Work Group (RASP) and encouraged the administration to adopt its recommendations.

Below is the list of metrics developed by the RASP Work Group.

1. Indirect Cost Recovery (ICR) / Assigned Square Feet (ASF)
2. Expenditures / ASF
3. % ASF "PI Pending"
4. Rooms "PI Pending" > 2 years
5. ASF / Occupant

Parnassus Master Plan Steering Committee

The SPC conferred with Senate representatives on the Parnassus Heights Master Plan Steering Committee (PHMPSC).

- The Senate representative on the PHMPSC is Xiao Hu.

UCSF created four working groups that report to the PHMPSC. The Senate appointed a representative to each of the working groups.

- The Senate representative for the *Central Research Labs Work Group* is Kathy Yang.
- The Senate representative for the *Research Work Group* is Carol Dawson-Rose.
- The Senate representative for the *Education Work Group* is Sarah Hughes.
- The Senate representative for the *Data Work Group* is Srikantan Nagarajan.

The Research Work Group reported to the Senate that it relied on two task force reports from the Academic Senate:

The Research Work Group recommended the construction of a new research building at Parnassus Heights on an expedited timeline. The administration has indicated support for that recommendation and is exploring feasibility.

During the summer of 2019 the Parnassus Master Plan Steering Committee concluded its work. The administration is beginning the next phase of the process and has reached out to the Senate for representation on future task forces. SPC unanimously supported recommendations of the

Parnassus Heights working groups' reports.
