# Proposal to amend UCSF Division Bylaw 105

# Statement of Purpose:

It was brought to the Committee on Committee's (COC) attention on Friday, October 9, 2020 that the Committee on Faculty Welfare (CFW) needed to fill two temporary vacancies due to two of its members out on maternity leave in the 2020-2021 academic year. The issue of whether temporary appointments were possible was brought to the attention of the Committee on Rules and Jurisdiction (R&J) by COC and CFW.

After review of Division Bylaw 105, R&J found that it did not allow COC to make temporary appointments. Instead, Bylaw 105 states that a candidate appointed to fill a vacancy shall fill the full remaining term of the member who vacated the position. If COC did find a replacement for CFW, the CFW member taking parental leave would surrender their seat for the remainder of their term.

R&J, COC and CFW believes an amendment is necessary to allow COC to fill temporary vacancies, allow members to return to their committees after taking leave, and make the bylaws more family friendly. A committee member should not have to be penalized by giving up a committee placement because of parental leave, and a committee should not have to be understaffed when members take leave.

As a comparator, the UC Irvine Division of the Academic Senate allows the UCI Committee on Committees to appoint substitutes when standing committee members go on leave for a quarter. This process is outlined in the UCI Senate's <a href="Bylaw 60">Bylaw 60</a>.

It is intended that this amendment shall be effective immediately upon approval by the San Francisco Division.

#### Pros:

An amendment to UCSF Division Bylaw 105 will allow COC to improve its support to other Senate committees when a temporary or alternate membership appointment is deemed necessary, and/or to allow any ad-hoc type of appointments.

Allowing temporary appointments enables committees to be fully staffed while members are on leave, and it allows those members to be welcomed back to their committee service when they return.

Committees and committee members should not be faced with a choice between having a committee that is less effective because it is missing members and forcing members to give up their committee membership because of a life event.



Cons:

COC may have difficulty finding temporary committee members with short notices and temporary members may be difficult to find.

Temporary members may wish to remain for the full term of the vacant position.
